Appendix A - Summary and explanation of Proposed Constitution Changes 2018

Rename the 'Race Promotions Co-ordinator' committee post to 'Race Organiser' The change to 5 Management is proposed to bring the titles of the four committee posts that represent areas of the club's activity into line (the other three are Ladies' Team Manager, Men's Team Manager and Junior Organiser). Trophy Custodian is removed from the list of example committee appointed posts as this post has been disestablished.

Remove the requirement for a member who resigns and then rejoins to pay subs again for the same year. The change to 6 Membership has this effect.

Regrouping of clauses and correction A clause from 8 Finance is moved to 6 Membership resulting in a more logical grouping of clauses, and a correction is made to clause 11 (c).
