Treasurer's Report 2017-18

Throughout the financial year the club has continued to perform well, taking on new members and providing outstanding support and training to the senior and junior sectors of the club.

Race promotions has proved to be a highly successful area for Clayton, providing races such as Hameldon Hill, Mearley Clough and a never ending amount of races around Pendle Hill. This has allowed for hundreds of runners in the local area and beyond to compete and enjoy scenic tours of Burnley, Accrington and the Ribble Valley. This has allowed us as a club to invest in training our keen members and building a reputation of Clayton Harriers so the vest can be worn with pride.

Clothing sales are slightly down this year, however I do not see this to be a negative, the kit we wear is of high quality meaning we don't need to replace it every year. Some clothing stock has been written off during the year such as old fell t-shirts and car stickers which no longer hold a considerable value. Deb and Michelle have done a fantastic job of keeping up with orders and ensuring that everyone who requires kit gets it quickly and on time for events.

As it stands, I do not see a reason for the subscriptions to increase, however we are awaiting decisions on affiliation with Northern Athletics and possible changes to memberships for over 65's which will be tackled by the new committee. In the event of these decisions being made it may be required to increase the subscription to deal with the additional costs. At the moment, of the £25 for Seniors and £12 for Juniors, £15 of this goes to England Athletics fees, and the remainder of the money is used to run the club and support members in areas such as training and equipment.

From March until September of this year, the position of Treasurer has been short lived for me.

Due to a change in circumstances, I have had to resign as Treasurer and sadly also resign from the club.

I wish the committee and everyone at Clayton the best of luck with the future and hope to join my old team mates for a few races in the near future. I am sure Mark will do a great a job as my replacement and I have offered him my support with the coming year's accounts.
